Purpose and Scope

West Chester University ("WCU" or "University") seeks to provide a safe and secure learning environment for students, faculty, and staff of the University community. WCU has the authority to establish requirements and expectations for persons on University property.

Policy Statement

WCU students, faculty, and staff may use WCU parking lots and garages in accordance the rules, provisions and guidelines set forth in this policy.

Additional provisions for special circumstances may be granted to visitors guests wishing to park in and on university property, on a case by case basis under the appropriate university authority.

Procedures for students, faculty, and staff

- Parking permits are sold online via credit card only. There are no in person sales.
- Parking permits will be REQUIRED in all university parking lots during each semester.
- Parking permits are \$30.00. There are no refunds for parking permits. All Sales are Final.

Parking Permit Registration for students, faculty, and staff

- Online Registration is available upon announcement through campus communication, i.e. social media and email.
- All parking permits must be purchased online with a credit card unless you do not have WCU credentials to log-in online (USH or Aramark Employees).

Parking Ticket Holds and Appeals for students, faculty, and staff

All outstanding parking tickets and holds must be cleared prior to purchasing an annual permit.

Appeals

To appeal a parking violation, please follow the procedure below:

Appeal in writing at the Public Safety Parking Services office within 10 calendar days from the date the violation was issued. All appeals must be submitted on the official appeal form. Appeal forms are available at the Public Safety Parking Services office and online.

The following reasons are not considered sufficient grounds for an appeal:

- Forgetfulness
- Short parking duration
- Failure to display permit
- Inability to see sign
