WEST CHESTER UNIVERSITY OF PA
FEE ADJUSTMENTS FOR SPRING 2020 AND SUMMER 2020 TERMS

The COVID-19 pandemic that hit in the middle of the spring 2020 term forced the University to transition our current delivery of instruction (pre-pandemic) to alternative instructional modalities for the remainder of the spring 2020 term. Furthermore, in an effort to lessen the financial burden on our students, we made the decision to refund 50% of the following fees (EG and Auxiliary):

- ❖ Student Activity (SSI)
- ❖ Health
- ❖ Parking & Transportation
- ❖ Graduation
- ❖ Housing
- ❖ Food Service (including Flex)
- ❖ Sykes Union
- ❖ Recreation Center
- ❖ Auxiliary Enhancement

These fee reductions resulted in refunds of \$1.9 million in the E&G budget and \$8.45 million in the Auxiliary budget for a total of \$10.3 million that was returned to our students.

We also made the decision to waive these same fees for the Summer 2020 terms.

As such, we are requesting formal retroactive approval for the implementation of these fee reductions.
